

# “Perfect To Me” Love Story Contest

## Official Rules & Guidelines

The “Perfect To Me” Love Story Contest (“Contest”) is sponsored by Complete Weddings + Events in partnership with Tate Stevens.

By entering, participants agree to the following rules and requirements.

## 1. Contest Overview

Eligible couples will submit a short video sharing their “Perfect To Me” love story for a chance to win a special wedding guest appearance and live performance by Tate Stevens.

## 2. Eligibility

- Contest is open to legal residents of the United States who are:
  - 18 years of age or older at the time of entry
  - Currently booked clients of Complete Weddings + Events
  - Planning a wedding scheduled within an agreed-upon eligible event period
- Employees, affiliates, and immediate family members of the Sponsor are not eligible to win.
- Void where prohibited by law.

## 3. Contest Timeline

- **Submission Period:** July 1 – July 31, 2026
- **Public Voting Period:** Throughout July 2026
- **Winner Announcement:** August 2026

Sponsors reserve the right to extend or modify contest dates if necessary.

## 4. How to Enter

Participants must:

1. Record a video that is **30 seconds or less**
2. Share their “Perfect To Me” love story
3. Submit the video through the official contest submission page provided by Complete Weddings + Events during the submission period

## Video Requirements

- Maximum length: 30 seconds
- Must be original content created by entrants
- Must not contain copyrighted music, profanity, nudity, illegal activity, or offensive material
- Videos must not infringe on the rights of any third party

Incomplete or non-compliant entries may be disqualified.

## 5. Voting

- Public voting will take place throughout July 2026 on Tate Stevens website ([TateStevensMusic.com](https://TateStevensMusic.com)) and Tate Stevens & Complete Wedding + Events social media platforms.
- Individuals may vote once per day per valid email address/device, subject to Sponsor verification.
- Automated voting, bots, vote-buying, or fraudulent activity are prohibited and may result in disqualification.
- Sponsors reserve the right to remove suspicious votes or disqualify entrants for any manipulation of the voting process.

## 6. Prize

One (1) winning couple will receive:

- A special guest appearance by Tate Stevens at their wedding
- A live performance of Tate Stevens' new single, *Perfect To Me* at the wedding

## Approximate Retail Value

Prize value may vary depending on wedding location, travel requirements, and production considerations.

## 7. Prize Conditions

- Wedding date must be mutually agreed upon by the winning couple, Complete Weddings + Events, and Tate Stevens.
- If scheduling conflicts prevent attendance or performance, Sponsors reserve the right to substitute a prize of equal or greater value.
- Prize is non-transferable and may not be redeemed for cash.
- Winners are responsible for any applicable taxes or additional wedding expenses not specifically included.

## 8. Winner Selection & Notification

- The winning couple will be determined based on the highest verified public vote total combined with Sponsor review for authenticity and rule compliance.
- Potential winners may be required to verify eligibility and sign publicity/liability releases before receiving the prize.
- If a winner cannot be contacted or fails to respond within the required timeframe, an alternate winner may be selected.

## 9. Publicity Release

By entering, participants grant Complete Weddings + Events and Tate Stevens permission to use submitted videos, names, likenesses, wedding photos/videos, and related promotional content for marketing, advertising, and social media purposes without additional compensation unless prohibited by law.

## 10. Limitation of Liability

Sponsors are not responsible for:

- Technical failures or submission issues
- Lost, late, incomplete, or corrupted entries
- Unauthorized intervention or fraud
- Event cancellations, travel interruptions, or circumstances beyond reasonable control

Sponsors reserve the right to cancel, suspend, or modify the Contest if fraud, technical failures, or other factors impair the integrity of the promotion.

## 11. Privacy

Information collected from entrants will only be used for the administration of the Contest and related promotional communications in accordance with applicable privacy laws.
